# **Application for Membership**

We are pleased that you are applying for membership in the Bay View Association of the United Methodist Church ("Association"), a Chautauqua community recognized as a National Historic Landmark. We offer two types of Membership: (1) Associate and (2) Leaseholding for those named on a cottage lease.

The <u>Association's</u> By-Laws establish the requirements for membership, the minimum contents of this Application and the review and decision-making process. The Association does not take race, color, sex, disability, familial status, national origin, religion, religious beliefs or lack thereof, or sexual orientation into consideration when making membership decisions.

### **Membership Requirements**

An individual may be accepted as a Leaseholding or Associate Member upon a two-thirds vote of the Board of Trustees if the individual complies with the following qualifications and requirements:

- 1. Pays the initial membership fee, which shall accompany the membership application (\$300).
- 2. Completes and files the membership application form with the Association's administrative office.
- 3. Is at least twenty-one (21) years of age. \*
- 4. Is of good moral character and will support the Association's purpose and objectives.
- 5. Agrees to respect and preserve the history and values of the Bay View Association: "To enrich the human experience for individuals and families within Bay View and the surrounding community through a seasonal program of religious, educational, cultural and recreational opportunities, in a manner consistent with Christian values."
- 6. Provides at least four (4) reference letters attesting to the applicant's fulfillment of the above membership requirements from:
  - a. At least two members of the Bay View Association, excluding relatives of the applicant, members of the Board of Trustees and anyone associated with the transfer of the lease (if any); and
  - b. At least two persons of the applicant's choice, excluding relatives.
- 7. Completes a satisfactory interview with the Membership Committee or its designee and receives a favorable vote of the Committee affirming that the applicant is qualified and supports the Association's purpose and objectives.

<sup>\*</sup>The Articles of Association require a minimum age of 21.

### **Membership Application Instructions**

- 1. A separate Application is required for each individual seeking membership. If a couple seeks membership, each person must complete his or her own Application (including reference letters specific to each applicant).
- 2. Fully and accurately complete the Application. If you are seeking only Associate Membership, do not complete the "Application for Leaseholding Membership Addendum." If you seek Leaseholding Membership, you must complete that Addendum.
- 3. Submit the completed Application along with the initial membership fee of \$300 to the Association's office. If paid by check, please make your check payable to "Bay View Association."
- 4. Upon submitting your Application Bay View will request the reference letters identified in your Application. By submitting your Application, you authorize the Association to request, receive, use distribute (for the purposes of processing the application) and retain such information as part of the membership application and review process. One of the two references must be from a Bay View Leaseholding Member. The other may be either from an Associate Member or a Leaseholding Member. No two references may be from the same family, or members of the Board of Trustees, paid Association staff or anyone associated with the transfer of the lease (if any).
- 5. You will receive notification from the Bay View office when all the letters have been received. After, and only after you receive that notice, YOU MUST SCHEDULE an interview with representatives of the Membership Committee by emailing a request to <a href="mailto:memberapps@bayviewassociation.org">memberapps@bayviewassociation.org</a> or by calling the Association's office at (231)347-6225. Your interview must be conducted in-person in Bay View with members of the Committee and should be scheduled during the Assembly Season (mid-June through mid-August). No interviews will be held during the period from November 1 May 1.
- The Membership Committee will consider your application only after your in-person interview. Memberships recommended by the Committee for approval are forwarded to the Board of Trustees for final review and approval or denial.
- If applying for Leaseholding Membership, the Addendum on page 10 of this application MUST be submitted and approved before lease transfers or cottage sales will be approved by the Board of Trustees.

Your application is active for eighteen (18) months from the date of submission. A six-month extension may be granted for good cause by the Membership Committee chair. Half of the initial membership fee will be returned to you if your application is not approved. If you withdraw your application or fail to provide a complete application, no refund will be made. The Association reserves the right to deny any Application for any reason or no reason, to the extent consistent with applicable law.
