Also, participants image and/or voice while engaged in Bay View activities may be copyrighted, used and/or published individually or in conjunction with other photography, video works, and recordings, for any lawful purpose including without limitation, trade exhibition, illustration, promotion, publicity, advertising and electronic publication. The undersigned also releases the Bay View Association from all claims for libel, slander, invasion of privacy, infringement of copyright or right of publicity, or any other claim related to the participant's image and/or voice.
